PRESIDENT'S MESSAGE

What a difference a year makes! At the commencement of 2020, bushfires and floods were ravaging different parts of Australia – affecting areas that had suffered years of drought and deprivation. As a College community, we were particularly concerned about the welfare of our former Administrator Helen Scruton and her husband Mark who were bunkered down in Bateman's Bay on the New South Wales South Coast, bushfires nearby. And then came COVID-19 ...

Thankfully, Helen and Mark were safe and have been able to divide their time between their home on the Coast and with family in Canberra. And, despite some fall away in candidate numbers, the College has managed to 'soldier-on' for another year. A huge thanks to our Administrator Rebecca, and to our two diligent Co-Ordinators Chris Reddick (Music) and Ros McIvor (Speech) for their organisational skills in ensuring that 2020 examinations proceeded with a minimum of disruption to usual routines. One of the strengths of our organisation is that its size allows us to be flexible and responsive to sudden change.

Sadly, in May 2020, we lost another of ACM's links to the College's foundation years, the late 1960s. Lillian Adell Patrea ('Patrea') O'Shea passed away on 23 May at the age of 83 years. Her death was quite sudden and unexpected. A Catholic funeral service was held in Toowoomba on 28 May 2020 officiated by her nephew Father Kevin McGovern. The College's message of condolence was sent to Patrea's immediate family, her children Andrea, Damon, and John. Patrea's husband (John) predeceased her. The Management Committee is investigating a suitable way to commemorate Patrea's over-fifty years' contribution to the College, as has been managed with other College identities. I thank Ros McIvor who penned an obituary for 'The Quarterly Voice' (the newsletter of The Communication, Speech and Performance Teachers Inc.) and parts of which are reproduced elsewhere in this briefing.

Apart from dealing with the challenges of COVID-19, 2020 marked the last year that the Australian College of Music will have results in higher grades of study (Grades 4 upwards) recorded on the Queensland Certificate of Education by the QCAA. The tertiary admissions body, QTAC, and the universities advised in 2019 that music and speech studies would not be recognised from any organisation to generate an 'equivalent rank' for the purposes of tertiary entrance. While it might be ideal to have a central recording document for all such co-curricular studies undertaken in Years 10-12, the reality is that as a small (and growing smaller) examinations body, the College could not justify the expense and the time that reapplication for 'recognition' involved nor the ongoing costs

associated with governance, especially for a small number of our candidates. The practical impact on students is minimal. I reiterate that this change in recording will have NO impact on a student's capacity to use an ACM level of study for tertiary entry purposes. The universities have said clearly that they will not use speech or music qualifications from any examining bodies for course entry purposes.

The Management Committee has also taken the decision not to organise an Awards Evening in 2021. In a sense, we 'dodged a bullet' in 2020; if held a week later, we would not have been able to hold the event as restrictions on numbers and social distancing protocols would have been operational. As a Committee, we had to make a decision for 2021 based on recent realities (such as the Brisbane 'lockdown' in January) and current health advice. Given that so many of our candidates reside outside of the south-eastern corner of the state and would need to travel at a time when to do so is both expensive and subject to sudden changes around access, the decision to cancel is sensible. The College's thanks go to Rebecca who will forward medals and certificates to hand on to the most successful 2020 candidates. Congratulations to these teachers and candidates, in particular.

Despite the challenges of dealing with COVID, examinations were conducted with professionalism by our panels of examiners. Our Music and Speech Co-Ordinators (Chris and Ros, respectively) are able to provide guidance about syllabus interpretation, resources, and approaches to examination day processes. They are the initial point of contact for teachers. As a Management Committee, we are alert to the demands of using facilities owned by entities other than the teacher such as school rooms and halls. We will endeavour be more aware of the timetables scheduled for examinations. Co-Ordinators will be considering if there are procedures that can be adopted to 'save time' in an examination program. For example, can performance material be trimmed from syllabi to make the examination experience less stressful for teachers, candidates, and examiners? Decoupling from QCAA recognition provides the College with greater autonomy and flexibility in changing syllabus requirements and being a more dynamic examining body. It must be reiterated that the College aims to offer an inclusive examination experience that is affirming of the diversity of its clientele.

From all indications, 2021 would seem to be another year when COVID will impact on teachers in their practices. It is too premature to describe these times as 'post-COVID' or 'normal'. The health advice is that even with widespread vaccination, it will take quite some time to achieve a 'new normal'. And who knows what that will resemble, exactly? (NO! ACM has no plans to examine online or by electronic submission as some examination bodies have chosen, and been technically able, to trial.) As a College, our decisions will continue to be informed by current health advice. If sudden changes to examining times are necessitated by government action, teachers and candidates will not be penalised financially as a result of any decisions that the College makes. There is no commercial insurance that can be accessed to recoup disruptions created by COVID-related decisions. We will do our best to accommodate teachers to negotiate the vicissitudes of the year. Let's hope that the general goodwill and cooperation from teachers that characterised 2020 is replicated in 2021.

Again, I extend my appreciation to the members of the Management Committee – Chris Reddick and Julie Vincent, and Ros McIvor and Marjory Compton – for their industry and goodwill. I know that their contributions to the day-to-day governance of the College are informed by the sense of collaboration that Patrea O'Shea always sought to foster and model herself. To our Administrator, Rebecca, we offer gratitude for her skills and patience, especially in dealing with recalcitrance. Rebecca has discharged her roles, as a secretarial and a financial manager, with a great deal of aplomb, confidence, and intelligent consideration of candidates' and teachers' needs.

I wish teachers, candidates, and friends of the College, the very best for 2021. Let it be a time for growth in both a professional and personal sense.

Syllabus Matters.

- Please read and reread the syllabus to ensure all requirements for the grade are covered by the students.
- Only list pieces chosen from the syllabus (except for List D), can be used for exams.
 If you wish to make substitutions please submit the names of the piece and a scan of the music (if possible) to the ACM Administrator as set out in the Regulations.
 These will be forwarded to me for approval

- In Prep 1 and 2, please be aware that it is compulsory to play the exercises from Dozen A Day shown under technical work in the syllabus.
- Please note that pieces chosen must be the original works of a composer and not arrangements of these works. (Only in the Syllabus for Modern Piano is this admissible.)
- All pieces should be played from the book from which it was taken. Photocopied pages should only be used as an aid to difficult page turns or some other difficulty in the music. Learning to turn pages effectively is a skill to be practiced.

SPEECH COORDINATOR REPORT

Happy New Year.

2020 was a strange year due to the COVID pandemic and its accompanying fears and restrictions. Many of us had to learn how to use, and then teach via Zoom. We really did not know from day to day if we were going to go into lockdown again. This meant for me, as Coordinator of Speech subjects, considerable uncertainty when attempting to program for exams. After all, Queensland is such a large state and different areas were going into lockdown at different times. Thankfully, my "Plan A" was implemented and examinations went ahead smoothly despite some flights being delayed. A number of studios had fewer entries - and some smaller studios did not submit any entries - but, overall, the number of entries was only slightly reduced compared with 2019.

Once again, I recommend that all Speech teachers be members of the CSPT Inc. (formerly SDTAQ Inc.). Details about membership can be found on their website: www.csptinc.org.au I also encourage you to attend the CSPT Inc. Conference on the evening of Friday 19th February & 8am to 4:30pm Saturday 20th February to be followed by the AGM. The Conference will be held at Iona College in Wynnum West. Details can also be found on CSPT Inc. website.

The 2021 Key-note Speaker is well-known author Isobelle Carmody. Her topic is "The Last Word". There are other interesting sessions with presenters whom I thoroughly recommend. These annual conferences are always very stimulating and a wonderful learning experience for all. Certificates of attendance are issued which can be kept for professional development records. Remember, you can also claim conference expenses as a tax reduction as it is considered professional development.

It is each teacher's responsibility to have their own public liability insurance and to be holders of a 'Blue Card' that is current. Liability insurance is available at a much cheaper rate if you are a member of the CSPT Inc. N.B. No insurance covers issues associated with a pandemic.

With regard to biological ages, school grades and ACM examination grades, please note that minimum ages and school levels are suggested minimums. For example, a student in Year 6, while they may 'qualify' to undertake a Grade 1 exam, may not necessarily have developed the vocal or performance skills for that level. So, they may be better to undertake a Prep 2 or 3 level for their first examination. A student in Year 11 may be better to attempt Grade 3 or 4 as their first exam.

Please note that the 2020 Syllabus stated for every exam "on entry to the examination room the candidate will introduce him/herself in a spontaneous and appropriate manner". This expectation applies to the syllabi for Speech and Drama and Public Speaking as well as for Speaking and Communicating. A courteous introduction is an important life skill. Unfortunately, too many students did not introduce themselves and show examination readiness or social awareness.

Please ensure that you are using the 2021 syllabus. You will notice some changes.

I look forward to seeing many of you at the CSPT Inc. Conference and hope that 2021 is a smooth running teaching year, relatively free of COVID. The Speech examiners look forward to working with you and your candidates again.

The **ANNABEL JESSIE GARRIOCK AWARD of EXCELLENCE** This Award celebrates the life of Annabel Garriock, who sadly passed away in 2009 at the age of sixteen. Annabel undertook examinations each year with the Australian College of Music. The presentation of this award recognises the commitment and work ethic of an outstanding Speech candidate who has completed Grade V in Speech and Drama or Speaking and Communicating. This award represents a book prize relating to Australian literature (to the value of \$50).

PATRICK RYAN ACHIEVEMENT AWARDS are presented annually to students in Years 7-10 in honour of Mr Patrick Ryan OAM, a founding member of this College, and a highly-respected educator and examiner. Each award carries a \$100 cheque to assist the recipient with further study. Criteria used in determining recipients include involvement with the College and consistency in achievement. Teachers can nominate candidates deserving of these awards and outline their work ethic, commitment, and consistency in achievement.

The SHEILA BIRCHLEY AWARD is granted annually in honour of ACM's co-founder, Mrs Sheila Birchley (nee Jones), B.Mus. (IUA.), FTCL, FLCM, FACM, LTCL, LLCM (TSM), A.Mus.A. A woman of outstanding substance, family dedication, a determined fighting spirit and incredible talents, Sheila Birchley initiated and founded the Australian College of Music in 1966. Together with Patrick Ryan, she was responsible for seeking Letters Patent for the ACM which were issued on 16th May 1968. Sheila focused on mandating content for College syllabuses that would be recognised both nationally and internationally. She worked tirelessly and passionately, to provide challenging syllabuses, to secure specific well-qualified, compassionate examiners, to uphold very high standards and to provide feedback and support to students and teachers. Sheila (a performer, teacher, examiner and adjudicator) gave her talents freely to those who were unable to afford tuition, helped the disabled, brought culture to the communities where she lived and, through encouraging teaching, developed the talents of many. Sheila initiated the annual ACM Awards Night to showcase students' talents. The Sheila Birchley Award carries with it a \$250 cheque to assist the recipient with his or her further study. Several criteria including performance achievement as demonstrated by examination results (both practical and theoretical components), ambassadorial qualities and potential are used in determining the recipient for each particular year.
